

You have 60 (sixty) days to call and activate and reserve any available dates within the following 12 (twelve) months.

Your gift is valid for a one-time reservation of a 4 (four) night/5 (five) day stay, in an Oceanfront Jr. Suite studio unit, for up to 2 (two) adults, at the Costa Sur Resort and Spa in Puerto Vallarta, Mexico only.
